SECTION 4

SPILL MANAGEMENT

HANDLING AND STORAGE

HANDLING

Avoid breathing mists or vapour. Prevent small spills and leakage to avoid slip hazard. Material can accumulate static charges which may cause an electrical spark (ignition source).
